Buyer agrees to have their puppy examined by a licensed Veterinarian within 72 hours after receiving the puppy. If the veterinarian finds the puppy to be unsuitable, return the puppy immediately. Changing your mind, family issues, or landlord problems do not warrant a refund. Failure to have the puppy checked by your Veterinarian voids this warranty, as does spaying or neutering your puppy before the age indicated below. Return contract agreement: If at **ANYTIME** the buyer no longer wants the dog, the breeder must be contacted and the buyer must return the puppy/dog along with the registration papers. If the dog is found at a shelter, rescue, or pound of any sort, the buyer may be subject to a penalty of \$5,000.00. I do not want any of my puppies to end up in a shelter or to be put down. I will work with the family to find the dog a new loving home.

If the puppy is declared to be unsuitable for sale or life threatening condition, genetic or hereditary problem, by a licensed Veterinarian, return the puppy along with all registration papers, along with a written report from Veterinarian to seller, within 3 days, and puppy will be replaced with one of equal value from the next litter. If the puppy should die within 48 hours, all registration papers and a Necropsy Report from the Veterinarian stating the cause of death, must be given to the seller, before a replacement puppy of equal value will be given. Death due to an injury or accident, neglect, or Hypoglycemia is not covered. Necropsy must be done at the buyers cost.

The puppy is guaranteed for one year from the puppies date of birth (/ /) for any life threatening congenital or hereditary disorders. The seller has the right to take the puppy to their own Veterinarian for a second opinion, before a replacement puppy will be given. NO CASH WILL BE REFUNDED. The seller is NOT responsible for any Veterinary charges, shipping charges, or delivery charges. The Sellers liability is limited to the price paid for the puppy, no other charges or fees. Any shipping expenses for returning the puppy or sending the

new puppy will be the buyers responsibility. All appropriate shots for the puppy's age have been given, and a record of this vaccination record will be given at pick up. However, puppies are not fully immune until the vaccination series is complete, at 20 weeks of age.

Seller does not guarantee against Hypoglycemia, internal/external parasites (worms, fleas, ticks) alopecia, non descended testicles, luxating patellas, hip dysplasia, hernias, cherry eye, stenotic nares, open fontanelle, overbite/underbite, coccidia, giardia, kennel cough, cancer, mange, scabies, growths, allergies, and other immune disorders .

The buyer agrees to have their puppy spayed/ neutered no sooner than a year old and no later than 18 months old.

All of my breeding dogs have been health tested and OFA certified for CAER, BAER, HEART, and PATELLAS as well as JHC and DM.

WE STRONGLY RECOMMEND TO NOT GIVE THE LEPTOSPIROSIS VACCINE TO YOUR BOSTON TERRIER. IT CAN RESULT IN A SEVERE REACTION OR DEATH!!
